#### Come and join us in Liverpool for this year's Summer Workshop!





As AI threatens to take the place of language professionals, one advantage we have as flesh-and-blood interpreters is our humanity. In this workshop we will practice interpreting with empathy, working on our delivery and performance in English to make our clients glad they chose a person over a robot. If you're uncomfortable interpreting consecutively from Japanese to English, particularly in front of an audience, come along and get some practice and tips in a safe, supportive environment.

Bethan is a Japanese-English interpreter based in London. She has been "full-time freelance" since 2010, interpreting in the fields of business, culture, and beyond. She has extensive experience of interpreting in front of an audience, both live and online, and also dabbles in presenting for TV and live events. # Session 2: Siddharth Agarwal CTA ACCA MSc, Senior Tax Manager at dns accountants

Optimising Your Pension: Tax-Efficient Retirement Planning

You'll gain clarity on how to structure contributions, utilise carry forward rules, and understand the interaction between pensions and income tax.

The discussion will also address the practicalities of accessing pension funds, detailing the regulations around withdrawals, tax-free lump sums, and drawdown strategies. Whether you're approaching retirement or just want to be more proactive, this session offers practical, expert-led insight to help you plan with confidence and make informed, tax-efficient decisions when planning for retirement.

The presentation will cover financial planning, pension savings, investments, etc., which are important to us as translators and interpreters working freelance.

# Session 3: Dr Christophe Fricker

Will we be 'replaced'?



#### Overview:

What I can do – and what I think we should all do more systematically – is scrutinise claims made by AI companies in terms of what their technologies will do, what they do, and how communication works. In all three areas, the discourse put out by tech companies is misleading; it is often mean and malicious; and very often it is also simply quite wrong.

I believe we need to look at discourses and remind ourselves of the nature of our work before we worry about what a machine can or cannot do. One of the smartest analyses of the world we live in is provided by Armin Nassehi in his book "Pattern," which I will take as one of my reference points.

Dr Christophe Fricker is Associate Professor of German and Translation at the University of Bristol. A former Founding Partner of NIMIRUM, a research and consultancy firm, and translator of sixteen books spanning various genres, he combines business and practical translation experience in his teaching. He is the recipient of a number of awards, with the most recent being the Zuger Anerkennungspreis for his planned translation of Vikram Seth's The Golden Gate.
